ACTIVIES: 2009-10:

Weekly visits to station: Our team visits the stations regularly, during our visits we identify a child in need & introduce the child to nearby centre.

Education: We encourage the children to attend school and try to enroll them in the nearby school C.O.G.F intends to give free tuitions to them with the help of local volunteer under 'I for U' campaign.

Provision: C.O.G.F staff visits the children in our project area every week. Here we distribute clothes food, toys, stationeries and books.

Music: This year Sagar Khade attended E.L.M in Bangalore to learn Drums.

Kid's camp: On April 26th and 27th we took our children along with children from another organization V.I.S.A to Alibaug. The two day stay in Alibaug was very enriching. The children enjoyed interacting with each other and exchanged thoughts, values and ideas we had organized different competition for the children there. The children thoroughly enjoyed the camp.
